The Elsmore Holdings Trust is a charitable trust established through the will of Bruce Rodney Elsmore, late of Rotorua. The purpose of the trust is for the relief of poverty and the advancement of education and is to be applied primarily towards the maintenance, education and advancement of children and young people in poor or needy circumstances. Special consideration is to be given to the alleviation of physical or mental distress.

### Grant information

Grant rounds run every 2 years (2019, 2021 and 2023 ongoing).

Who is eligible and what the grants can be used for:

- > Applicants must be New Zealand born or naturalised citizens and be under 20 years old as at the closing date of applications (30 September).
- > Applicants must require financial assistance towards their maintenance, education and advancement.

A maximum of \$2,000 will be awarded to an applicant.

### How to apply

Applications must be completed on this application form and emailed, with the required supporting documents, to Public Trust via [funding@publictrust.co.nz](mailto:funding@publictrust.co.nz) by **5pm on 31 October**. Please see the application form for the required documents.

### Late applications will not be accepted.

Applicants will be advised of the outcome of their application by 20 December.
